# Privacy Policy for Imblem

This Privacy Policy explains how **Imblem, LLC.** (“Imblem,” “we,” “us,” or “our”) collects, uses, discloses, and protects information when you visit *imblem.com* (the “Site”) and use our services (“Services”). It also describes your privacy rights and how the law protects you.

By accessing or using the Site or Services, you agree to this Privacy Policy.

## 1. Information We Collect

### 1.1. Information You Provide Directly

We collect information you provide when you register for an account, communicate with us, or use features of our Services. This may include:

- **Contact information:** name, email address, postal address, telephone number

## 2. How We Use Your Information

We use your information to:

- Protect against fraud, abuse, or illegal activity
- Comply with legal obligations

We do **not** use your personal data for any purposes that are inconsistent with this Privacy Policy.

## 3. When We Share Your Information

We may share your information in the following circumstances:

### 3.1. With Service Providers

We share data with trusted third-party service providers who help us operate and improve the Services (e.g., hosting, analytics, payment processors). These providers are authorized to use your information only as necessary to perform their services.

### 3.2. With Your Consent

We may share information when you request or consent to such sharing.

### 3.3. For Legal Reasons

We may disclose information to comply with law, respond to legal processes, prevent harm, enforce our Terms, or protect rights or safety.

### 3.4. Business Transfers

If Imblem undergoes a merger, acquisition, or sale of assets, your information may be transferred as part of that transaction.

We do **not** sell personal information for direct advertising or marketing without explicit consent.

## 4. How We Protect Your Information

We use administrative, technical, and physical safeguards to help protect your personal information. However, no method of transmission or storage is 100% secure, and we cannot guarantee absolute security.

## 5. Your Choices and Rights

This approach helps ensure compliance with laws like COPPA.
